CONCESSION STAND

Concession income is vital to the existence of the ballpark, and adults who volunteer to work help the ballpark survive. Registration fees in no way cover the expenses of running the ballpark. Therefore, Jasper County Boys and Girls Park is once again asking each family to donate some time this summer at the ballpark.
